OAKLAND PUBLIC ART ADVISORY COMMITTEE September 12, 2022 RESOLUTION NO. 1

ADOPT A RESOLUTION DETERMINING THAT CONDUCTING IN-PERSON MEETINGS OF THE PUBLIC ART ADVISORY COMMITTEE AND ITS COMMITTEES WOULD PRESENT IMMINENT RISKS TO ATTENDEES' HEALTH, AND ELECTING TO CONTINUE CONDUCTING MEETINGS USING TELECONFERENCING IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 54953(e), A PROVISION OF AB-361.

WHEREAS, on March 4, 2020, Governor Gavin Newsom declared a state of emergency related to COVID-19, pursuant to Government Code Section 8625, and such declaration has not been lifted or rescinded. See https://www.gov.ca.gov/wp-content/uploads/2020/03/3.4.20-Coronavirus-SOE-Proclamation.pdf; and

WHEREAS, on March 9, 2020, the City Administrator in their capacity as the Director of the Emergency Operations Center (EOC), issued a proclamation of local emergency due to the spread of COVID-19 in Oakland, and on March 12, 2020, the City Council passed Resolution No. 88075 C.M.S. ratifying the proclamation of local emergency pursuant to Oakland Municipal Code (O.M.C.) section 8.50.050(C); and

WHEREAS, City Council Resolution No. 88075 remains in full force and effect to date; and

WHEREAS, the Centers for Disease Control (CDC) recommends physical distancing of at least six (6) feet whenever possible, avoiding crowds, and avoiding spaces that do not offer fresh air from the outdoors, particularly for people who are not fully vaccinated or who are at higher risk of getting very sick from COVID-19. See https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html; and

WHEREAS, the CDC recommends that people who live with unvaccinated people avoid activities that make physical distancing hard. *See https://www.cdc.gov/coronavirus/2019-ncov/your-health/about-covid-19/caring-for-children/families.html*; and

WHEREAS, the CDC recommends that older adults limit in-person interactions as much as possible, particularly when indoors. See https://www.cdc.gov/aging/covid19/covid19-older-adults.html; and

WHEREAS, the CDC, the California Department of Public Health, and the Alameda County Public Health Department all recommend that people experiencing COVID-19 symptoms

stay home. *See* https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html; and

WHEREAS, persons without symptoms may be able to spread the COVID-19 virus. *See* https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html; and

WHEREAS, fully vaccinated persons who become infected with the COVID-19 Delta variant can spread the virus to others. *See* https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html; and

WHEREAS, the City's public-meeting facilities are indoor facilities that do not ensure circulation of fresh / outdoor air, particularly during periods of cold and/or rainy weather, and were not designed to ensure that attendees can remain six (6) feet apart; and

WHEREAS, holding in-person meetings would encourage community members to come to City facilities to participate in local government, and some of them would be at high risk of getting very sick from COVID-19 and/or would live with someone who is at high risk; and

WHEREAS, in-person meetings would tempt community members who are experiencing COVID-19 symptoms to leave their homes in order to come to City facilities and participate in local government; and

WHEREAS, attendees would use ride-share services and/or public transit to travel to inperson meetings, thereby putting them in close and prolonged contact with additional people outside of their households; and

WHEREAS, on October 19, 2021 the Public Art Advisory Committee adopted a resolution determining that conducting in-person meetings would present imminent risks to attendees' health, and electing to continue conducting meetings using teleconferencing in accordance with California Government Code Section 54953(e), a provision of AB-361; now therefore be it:

RESOLVED: that the Public Art Advisory Committee finds and determines that the foregoing recitals are true and correct and hereby adopts and incorporates them into this resolution; and be it

FURTHER RESOLVED: that, based on these determinations and consistent with federal, state and local health guidance, the Public Art Advisory Committee renews its determination that conducting in-person meetings would pose imminent risks to the health of attendees; and be it

FURTHER RESOLVED: that the Public Art Advisory Committee firmly believes that the community's health and safety and the community's right to participate in local government, are both critically important, and is committed to balancing the two by continuing to use teleconferencing to conduct public meetings, in accordance with California Government Code Section 54953(e), a provision of AB-361; and be it

FURTHER RESOLVED: that the Public Art Advisory Committee will renew these (or similar) findings at least every thirty (30) days in accordance with California Government Code section 54953(e) until the state of emergency related to COVID-19 has been lifted, or the Public Art Advisory Committee finds that in-person meetings no longer pose imminent risks to the health of attendees, whichever occurs first.

- **1.** Welcome/ Roll Call / Meeting called to order at 5:40 p.m. Information on City of Oakland Boards and Commissions public comment procedures was presented.
- 2. Public Comment: No comment was provided.
- 3. Action Item: Adopt a Resolution Determining that Conducting In-Person Meetings of the Public Art Advisory Committee Would Present Imminent Risks to Attendees' Health, and Electing to Continue Conducting Meetings Using Teleconferencing in Accordance with California Government Code Section 54953(e), a Provision of AB-361. Public Art Coordinator Kristen Zaremba stated that the Committee must adopt the resolution before conducting business for this and all future remote meetings until further notice. Motion: C. Roundtree-Baaqee moved to approve the motion. E. Murphy seconded. J. Kessler Aye; M. Ramirez Aye. Y. Pinkusevich Aye. Motion passed unanimously.
- 4. Action Item: Review and Approve Public Art Advisory Committee Minutes from the January 10, 2022 PAAC Meeting. C. Roundtree-Baaqee moved to approve the minutes. M. Ramirez seconded. Y. Pinkusevich Aye; E. Murphy; J. Kesseler Aye. Motion passed.
- 5. Action Item: Review and Approve Mural Design Proposal by Cultural Funding Neighborhood Voices Program Grantee David Burke, for the PG&E Substation located at 5143 Shattuck Avenue. K. Zaremba introduced the item, noting that the proposal is for a mural funded by the City through a Neighborhood Voices grant for PGE property, and welcomed the Oakland artist David Burke to introduce the project. This is one in a series of murals called Love Letter to Oakland, which originated during the Oakland Mural Festival, intended to recognize and honor artists contributing to the Oakland arts community. The subjects of this mural

unfortunately include two artists, Hung Liu and Michael Morgan, who recently passed, as well Key Choice, and the Twin Walls Mural Group. Additional murals are planned for the future. Work is scheduled to start in the third week of May, including a community painting day. The overall budget is roughly \$17,000, funded by the Neighborhood Voices grant and PGE. Oakland based Pancho Pescador and Jovak Yabon will assist, in addition to some younger emerging artists. PAAC members complimented the artist and thanked him for his work. They noted the quality of the design, the intergenerational composition of the artists included and the thoughtfulness of the work. Additionally, they asked whether there would be plans for future maintenance. There is a plan in process to address light maintenance for the work for 5 years. Zaremba noted that the City encourages PG&E to honor the artists' efforts and to anticipate longevity as the mural is anticipated to become a beloved landmark in the community. Burke also noted it is important to monitor the artwork to ensure its longevity Motion: E. Murphy moved to approve the Mural Design Proposal by Cultural Funding Neighborhood Voices Program Grantee David Burke, for the PG&E Substation located at 5143 Shattuck Avenue. C. Roundtree-Baagee seconded the motion. C. M. Ramirez Aye; Y. Pinkusevich Aye; J. Kesseler Aye. Motion passed unanimously.

- 6. Action Item: Review and Approve Mural Design Proposal by Cultural Funding Neighborhood Voices Program Grantee Debra Koppman, for the True Buddha Vijaya Temple located at **3440 Foothill Blvd.** Zaremba presented the mural proposal, as the artist was unable to attend the rescheduled committee meeting, and described the project plan, noting that the Unity Council is also a funder for the project. The artist has already started work on the project, with a budget of approximately \$14,000, including a Cultural Funding grant for \$7,000. The budget includes an in-kind donation of the artists' time. Finally, the artist has agreed to light maintenance for up to 5 years. The Unity Council would be responsible for compensating the artist for any comprehensive maintenance. Committee members complimented the artist on her design, and asked if there was a plan for the transition from the main wall to the adjacent building to create a seamless composition. Additionally they acknowledged the artist for her generous contributions and expressed concern for artists' compensation for the initial project and future maintenance. Staff noted the artists' optimistic approach to budgeting for project realization with the grants program, which is intended to support "neighborhood voices" even if the work lasts for a day, a month, or years. Staff always encourage the artists to ensure the terms are clearly articulated in their agreements with property owners, on terms that the artists are comfortable with. Committee members discussed ongoing maintenance needs, and if there is consideration for a nominal maintenance fund for sustaining projects. The challenge is that the grants program runs on an annual cycle, and there is more demand for the support of new art over maintenance of existing. Staff and Committee members agreed to pursue the topic. Motion: M. Ramirez moved to approve the Mural Design Proposal by Cultural Funding Neighborhood Voices Program Grantee Debra Koppman, for the True Buddha Vijaya Temple located at 3440 Foothill Blvd. Y. Pinkusevich seconded. C. Roundtree-Baagee Aye. E. Murphy Aye. J. Kesseler Aye.
- 7. Action Item: Review and Approve Project Backboard Mural Design Proposal by Dan Peterson / Project Backboard with Artist Adia Millett for the Lowell Park Basketball Courts at 1180 -14th Street. Zaremba introduced Dan Peterson, founder of project backboard, and PAAC 9-12-22 Item IV

Hank Phan, Capitol Projects staff for Oakland Parks and Recreation (OPRYD). Zaremba noted that the proposal is the next in a series of projects commissioned by Project Backboard for Oakland's parks and basketball courts. The first project reviewed by the PAAC was designed by Oakland artist Muzae Sesay, for the Rainbow Recreation Center, concurrent with the other public art works commissioned by the City for the Center's renovation in 2018. A second project designed by Oakland artist Alicia McCarthy was presented to the PAAC two year later. As the third project proposal for Oakland, each work delivered by Project Backboard is treated as a gift to the City and requires approval from the City Council. Hank Phan, Assistant Capital Improvement Coordinator (OPRYD) presented the proposal for Lowell Park, which is a two full court in West Oakland, just off 14th Street. Project Backboard worked with OPRYD staff to determine which courts and facilities were most in need of the improvements. Adia Millett was selected to create the designs for this project. The artist selected colors and a composition to honor the local community, entitled "Taking Flight," as a kite or a basketball takes flight. The gift in place court resurfacing will go to Council for approval and be installed by the Project Backboard team and Dan Peters using appropriate court-surfacing paints. The painted design, applied to a new court surface, is anticipated to last for a minimum of five years, although they can last longer. Staff and committee members asked about emerging artist involvement, community engagement and on-site signage to alert visitors to the project history, noting it would be valuable to provide more context and acknowledgement regarding the artist's work. Currently there is no plan for signage, but staff will research the opportunity. The work is considered temporary as it will not be maintained or restored once it ages. Committee members asked about promotional efforts on the City website regarding these projects and plans for future maintenance. Staff acknowledged the suggestion and committed to bringing it back to the Cultural Affairs Division as part of ongoing discussions regarding increased communications in CAD and how to cross pollinate those efforts with OPRYD. Committee members thanked Hank Phan for his work.

Motion: C. Roundtree-Baaqee moved to approve the Project Backboard Mural Design Proposal by Dan Peterson / Project Backboard with Artist Adia Millett for the Lowell Park Basketball Courts at 1180 -14th Street. E. Murphy seconded. M. Ramirez Aye. Y. Pinkusevich Aye; J. Kesseler Aye.

- 8. Informational Item: Staff Updates on Current Projects and Program Activity
 - a. Oakland Art Murmur Public Art for Private Development Walking Tour Report.

 Zaremba reported on an Oakland Art Murmur tour staff were asked to participate in leading shared images from the successful Public Art walking tour held in April. She noted the tour was well attended (approximately 35 people) and featured work by Squeak Carnwath, Taraneh Hemami and David Huffman, as well as Johanna Poethig, and included Sorell Raino-Tsui and some fabricators who spoke about their involvement. Zaremba noted that another public art consultant, Danielle Fox Slate Contemporary, would like to feature projects on a future tour. Zaremba noted it was a beneficial way to collaborate on efforts to share more public information. Finally, Zaremba noted that staff would like to target emerging Oakland artists on a future tour.

- b. General Program Updates: Zaremba reported on many community and privately driven projects which provide opportunity for the City's departments to work together on creating a transparent and seamless process for artists, while also highlighting the PAAC's role, and the due diligence others must apply to the work they propose. While ongoing Cultural Affairs staff shortages continue to cause some delays, Zaremba reported that an artist has been selected to work with the Cultural Strategist in Government (CSIG) on artist outreach efforts and professional development opportunities for artists interested in public art. The strategist will not be working for the City but functioning as a partner to transform the outreach efforts for the program. Committee members expressed support for the future collaborative efforts. Zaremba reported on the efforts of the Cultural Affairs Division, the recent event hosting the National Endowment for the Arts Chair Dr. Jackson and the efforts of everyone on the PAAC to uplift the cultural lives of all Oakland residents. Finally, a future installation to be realized by RBA Creative and the Smith Group, entitled Society's Cage, will be located on Frank Ogawa Plaza in May. Staff have returned to City offices part time and continue to work on efforts to reengage community. Committee members thanked the staff for all the updates and asked for ongoing outreach communications regarding future events.








The Bay Area Mural Program (BAMP) a non profit mural art organization located in Oakland, CA, requests to install a community-inspired mural on the outdoor field house building located in the Northwest corner at Mosswood Park (near basketball courts). BAMP is a mural organization that inspires youth educational programs with some of the Bay Area's most skilled artists. BAMP manages and facilitates the creation of public and private art murals. BAMP is the culture keepers of intergenerational artistic education. BAMP plans to work in collaboration with local community leaders and youth to design and install a mural at Mosswood Park to provide community representation and celebration of park history and visitors.

Parks Recreation Advisory Commission (PRAC) unanimously approved the request to install a mural on the field house at Mosswood Park. For funding, BAMP was awarded a Wells Fargo Environmental Revitalization Grant of \$15,000 to install a mural on three of the walls of the field house building. BAMP has delineated \$2000 from the grant monies to plant new ornamental trees and flowers for landscaping upgrades around the field house. The field house building walls currently have graffiti and other negative imagery on them, primarily due to the unhoused living at the park (Exhibit A). It is disheartening to visit the park daily and view such egregious graffiti in a public park. It sends the wrong message to our youth and park patrons.

This is a community mural that will reflect positive messaging and community values and shows that all people are welcome at Mosswood Park. The goal is to share the stories of people who visit and live around the park. We received 528 community survey responses about the landscaping portion of the project (Exhibit B), and 15 online survey responses about the mural installment. The mural is intended to bring various communities together; younger and older generations, and youth who experience similar marginalization due to race, gender identity, and background. We want to depict the voices and icons of the past like the Mosswood Legends, the Moss family, and the Children Theater Performances, and incorporate the park ecology.



Mosswood is known for large concerts such as The Mosswood Meltdown, Oakland Carnival, and Dream Day events that welcome 3000 plus people to the park. We plan to create positive imagery that will reimagine this space as a collective space for everyone.






MATERIALS AND METHODS PLAN

The public art mural for Mosswood Park is to be painted using high-quality exterior house paint, and sealed using the clear coat and UV protectant called TSW. The artwork will be designed by local artists Derrick Shavers and Andre Jones and executed by Derrick Shavers and Andre Jones of the Bay Area Mural Program.

The mural will be painted using rollers, brushes, paint sprayers, and other traditional painting methods. The piece will be scaled to size using a grid system, or projection. Once complete we will seal the mural with a paint sprayer and brush using TSW mural sealant. This sealant is a UV protectant that will ensure quality color for up to 30 years. It is also an anti-graffiti coating which is addressed in detail in the Maintenance Plan.







Project Narrative

ARTogether and the Center for Empowering Refugees and Immigrants (CERI) launched the Southeast Asian Street Art Workshops (SEASAW) Program in the Fall of 2021. The goal of SEASAW is to support a year-long program of art activities for at-promise youth from refugee and immigrant families who are impacted by the justice system and ICE, meeting weekly to gather, learn, design, and paint a community mural in East Oakland as the culmination of the project.

SEASAW's mural project, funded by the California Arts Council and the City of Oakland's Neighborhood Voices grant, will be painted on the wall of the Center for History & Community in Peralta Hacienda Historical Park, located at 2484 Coolidge Ave. The mural will be displayed on the southwest-facing wall at Coolidge Ave and Hyde St.

This mural will be located in the heart of East Oakland at Peralta Hacienda Historical Park, which serves as an educational, cultural, and ceremonial space for many different communities in Oakland. The park is the site of the annual Oakland Cambodian New Year celebration, and is a familiar space for many in CERI's community.

The mural's location was selected because of its long-standing significance to SEASAW participants, their direct communities, and to the diverse communities of Oakland at large. SEASAW's involvement with Peralta Hacienda will help to strengthen the networks between Oakland's Southeast Asian community and all other communities that convene at and utilize this public space.

This Project seeks to bring new opportunities to system-impacted youth who have limited access to education, arts, and creative spaces. The nearby Clinton Park and Eastlake neighborhoods are burdened with poverty, gang violence, and many of the other burdens of an East Oakland neighborhood. These include a lack of community investment, marginalized BIPOC groups, and under-maintained public areas. With endemic systemic and societal obstacles — sexual exploitation, prejudice, threat of deportation, and racial profiling — it is important that youth from these neighborhoods and backgrounds are given safe spaces to explore art and creativity, potentially sparking a life-long interest in the arts. These neighborhoods feature many immigrant-owned businesses and immigrant residents from East and Southeast Asia, communities which have experienced increased prejudice due to the racially-charged narratives of Covid-19. Youth in these communities face these burdens daily, with gang influence and racially-biased policing leading to distressingly-high youth incarceration rates and low high school graduation rates.

Through the creation of the Project's mural, participants are having the opportunity to express their stories and values in a public venue, investing system-impacted youth in the welfare and character of their community.

The lead artist for the SEASAW project is the Khmer-American mural artist Pat Kong, who has co-lead weekly 2-hour sessions with 12-20 participants between the ages of 11 and 20 for more

than six months. Drawing from successful youth leadership models developed at CERI, sessions are divided into three modules including Arts & Social Justice Education, Identity & Storytelling and Mural Art. So far we have held 34 weekly workshops during which youth participants have learned about Public and Personal Narratives, Culture and Identity, Symbolism, Art and Social Justice, visited Mural Sites in Oakland, and brainstormed about Mural Design. Youth were closely involved in the design process of the mural. During those workshops youth were able to express their stories and experiences in the form of artwork that was used as inspiration for Pat Kong's mural design. Youth participants shared the challenges in their community, their personal challenges, and the repercussions of the pandemic on their mental health. Youth expressed the desire of their identity and culture to be represented as well as to focus on positivity, hope, and the need to bring change in the world. After all these events, Pat Kong worked on the design that is appropriate for the facade and lifts up and embraces the ideas of the youth participants. The design represents harmony, peace, and hope in the daily battle of social justice and mental health issues.

Mural Design

Today, youth are confronted with a variety of societal issues, bringing conflict, stress, and injustice. In the mural's design, demonstrating individuals displayed on the right of the mural display this conflict and a striving for a better world. They are shown in black silhouettes, with the intention not to overpower or distract from the image of a young child in the center of the mural.

At the center of the mural is a mediating young child who represents hope, peace, and a positive future. Sitting on a sacred lotus flower, which symbolizes enlightenment, creativity, and purity, has a special importance in Khmer (Cambodian) culture. In Buddhist symbolism, the lotus represents purity of the body, speech and mind. Thus, the child sitting on the lotus flower signifies rebirth and blossoming youth. By meditating, the youth connects with and gathers energy from their ancestors, symbolized by temples, and harnesses strength from the surrounding world of nature, with palm trees and a waterfall, symbols of harmony and peace.

A highlight of the mural is the blue halo with an oak tree surrounding the child. The color blue was chosen to represent the ocean, sky, and a sense of calmness. The child is in the halo's realm, allowing them to remove thoughts of stress and connect with nature. The oak tree in the halo and the bridge in the background are included to connect them to their roots, and to their hometown of Oakland, the Bay Area, and the community they live in.

This mural hopes to serve as a reminder of what youth want to see changed in the world, and as a reminder that youth have the strength, resilience, and power to create a better future, because they are the future. The mural is scheduled to be painted by Pat Kong in collaboration with the youth participants of SEASAW in mid- to late-Summer 2022.

Roles and Responsibilities

Pat Kong, Lead Artist, is solely responsible for creation and implementation of the mural, and has been responsible for co-leading the weekly workshops throughout the Project.

Zeenna Stapper, Youth Program Manager, and **Elijah Chhum**, Youth Program Coordinator, from the Center for Empowering Refugees and Immigrants (CERI) have been responsible for program promotion, outreach, engagement, strengthening relationships with at-promise youth, lesson planning, co-facilitating the workshops and field trips, fostering partnerships with Peralta Hacienda Historical Park, and building a bridge between youth participants and the Lead Artist.

Miguel Lopez, Marketing Director & Events Producer, Peralta Hacienda Historical Park will be assisting with logistics and coordination on site.

Mory Chhom, Program Director for Youth and Families, Center for Empowering Refugees and Immigrants (CERI) provided a vision and direction for this program. She supported the program development and design and made the connection, built rapport and sparked interest and engagement of the program's lead artist, Pat Kong.

Polina Marso, Community Arts Program Manager at ARTogether, is an artist herself and has supported this program's administrative needs, including development, surveys, evaluation, and reporting.

Kajal Shahali, Youth Program Manager at Refugee & Immigrant Transitions, was invited to the program's youth space as a special guest facilitator, and has shared her experiences in exploring public narratives, which have helped our youth participants translate their creativity and stories into this mural. Guided by Marshall Ganz's "Public Narratives" leadership-development theory, youth have learned and practiced storytelling as an empowering tool to share their narratives with the world. Identities, backgrounds, and intersectional connections were explored, spanning verbal and visual art forms.

Artist Bio

Pat Kong is a Cambodian-American artist who was born in a refugee camp in the Philippines and raised in Oakland, California. Inspired by his father, one of the few artists to survive the Cambodian Genocide, Kong began exploring art at an early age. Recognizing the impact of large-scale cultural murals in his East Oakland neighborhood, Kong dedicated his artistic talents to benefit the community, promoting messages of social justice, Southeast Asian beauty, and Cambodian pride. Today, Kong has over 20 years of experience painting iconic Oakland murals, with featured art at the Bay Area Mural Festival, Eastside Arts Alliance, Oakland's Marin Way Murals, and numerous other public spaces throughout Oakland.





Community Outreach / Support Documentation

ARTogether and CERI have reached out to 18 youth at the beginning of the project: two-thirds are second-generation Khmer refugees of the Cambodian genocide, with other participants from Chinese-, and Vietnamese-American immigrant backgrounds. 15 students originally signed up, which was our ideal target. Registration for the program has since increased to include over 20 participants between the ages of 11-20. Many of the current participants are students who have been involved in art, education and mental health programs at CERI in the past. The majority of participants learned about SEASAW through word-of-mouth. Additionally, to reach at-promise youth the SEASAW program has been promoted through ARTogehter's website. 

This Memorandum of Understanding (MOU) is between **Peralta Hacienda**, and **ARTogether** for the purpose of implementing **A Community Mural at Peralta Hacienda Historical Park**, **2484 Coolidge Ave**, **Oakland**, **CA 94601** (southwest-facing wall of the Center for History and Community at Coolidge Avenue and Hyde Street). The size of the Mural wall is: over all facade: 369" W x 120" H, Main doors: 111" W x 89" H, HVAC door: 28" W x 89" H, Window: 69" W x 9" H and the painting of the mural will take place between 7/30/2022 - 8/29/2022 (depending on PAAC approval).

ARTogether, through grants from the City of Oakland Cultural Funding and the California Art Council, and in partnership with the Center for Empowering Refugees and Immigrants (CERI) developed A youth mural project with the purpose of bringing new opportunities to system-impacted youth who have limited access to education, the arts, and creative spaces. Through the creation of the Project's mural, youth will have the opportunity to express their stories and values in a public venue, investing system-impacted youth in the welfare and character of their community.

- ARTogether will provide art supplies and equipment, and compensation of the artist(s) and any
 other costs that may occur during the painting and preparation of the wall. ARTogether will
 provide assistance in maintaining the mural up to five years from the date of this agreement.
- The final design of the mural will be approved by ARTogether, Peralta Hacienda and the Center for Empowering Refugees and Immigrants (CERI) and Park Art Advisory Committee (PAAC).
- Peralta Hacienda agrees to let the mural be painted on (southwest-facing wall of the Center for History and Community, 2484 Coolidge Ave, Oakland, CA, 94601) free of charge.
- Peralta Hacienda agrees to give access to the property during the painting period process between 7/30/2022 8/29/2022.
- Peralta Hacienda agrees to not repaint, or destroy the mural for at least five years from the date of this agreement.
- Peralta Hacienda agrees to immediately inform ARTogether in case any damage or vandalism has occurred to the mural.



Project Narrative.

The Community Unity Mural Project ("Project") is a collaborative project led by ARTogether, a 501(c)(3) Oakland- and District 2-based nonprofit organization which provides art programs to support refugee and immigrant communities, in partnership with the Office of Council President Nikki Fortunato Bas. This participatory community mural project, funded by the California Arts Council and the District 2 Council office, will be sited on the supporting wall beneath the City-owned tennis courts, located at 1701 East 19th Street. The mural will be displayed on the southwest-facing wall at Foothill Blvd and 18th Ave at the base of the courts (120 ft. 8 in. \times 3 ft. 2 in. - 4 ft. 7.5 in.).

The Project reflects a renewed effort by community partners and local government to work together to activate and improve quality of life, cleanliness, community safety, and economic development in the San Antonio neighborhood, especially important as we emerge from the destabilizing and disconnecting impacts of COVID-19; and to promote use of San Antonio Park by the many youth, immigrant and refugee community members in the surrounding area.

The goal of the Project is to have the community voice be the center of this mural design and bring together members of the community – including local youth, families, elders, surrounding business owners, and unhoused neighbors – to co-design and paint a mural that reflects the diversity and cultural richness of the San Antonio and Eastlake neighborhoods of Oakland, which is home to a wide range of neighbors from the Asian, Pacific Islander, African, and Latinx diasporas.

The mural will promote community building, community healing, violence prevention, and participatory engagement while activating and beautifying a highly utilized public park and primarily people of color/immigrant-owned business corridor that has experienced ongoing public safety, blight, and quality of life challenges, as well as building on the historic legacy of culture keeping and artistic production in the San Antonio neighborhood.

Muralist Cece Carpio, whose work focuses on stories of immigration, ancestry, resistance, and resilience, is serving as the lead artist partner for the Project. Carpio has produced and exhibited work internationally, has extensive experience supporting Bay Area communities through artistic partnerships (such as with UC Berkeley, Oakland Museum of California, and Yerba Buena Center for the Arts), and is a former Public Art Advisory Commissioner for the City of Oakland.

In Winter 2022, ARTogether performed extensive outreach to community organizations – including EastSide Arts Alliance, BAWAR, Friends of San Antonio Park, East Bay Asian Youth Center, the Center for Empowering Refugees and Immigrants, and many others – inviting them and their community members to take part in the Project. Following our outreach, ARTogether hosted two Community Design Workshops on March 12th and April 9th, each with social distancing in place. Both workshops were led by Cece Carpio. Community Design Workshop #1 was held outdoors in San Antonio Park, where participants discussed the history of San Antonio Park, shared their favorite memories of the park, and brainstormed ideas together to lay the

important groundwork for the design of the Community Mural. On April 9th, Community Design Workshop #2 was held at EastSide Arts Alliance under careful guidance of lead artist Cece Carpio, where community members took the ideas for the Mural Design further, visualized them through collaging and sketching. Using symbols, historical knowledge of the park and common values, participants put together the communal mural draft.

The lead artist designed the mural immediately following these workshops, including the ideas and inspirations from the Community Design Workshops in the sketch. The mural will be painted by Cece Carpio in collaboration with an Assistant Artist selected by Carpio in late Summer 2022.

Mural Design.

Described above, the proposed mural design for San Antonio Park has been developed from a series of community workshops with residents, community organizations, and students from local schools in the San Antonio neighborhood. In our community workshops, participants expressed a desire to represent activities in the park that make the site vibrant. Participants also voiced interest in depicting the history of the park and the neighborhood, alongside many of the natural elements that make San Antonio Park unique. The plants included in the background of the design are directly derived from the community garden grown by residents with vegetations that are culturally symbolic of the various places that they come from. Sports depicted in the design illustrate many of the dominant activities enjoyed everyday in the park. And the oak trees and hawks illustrated in the design are native species and plants found in the park, reflecting the park's history as well as the history of Oakland.

Roles and Responsibilities.

Cece Carpio will be the lead artist for the Project, and is solely responsible for the final design and painting of the mural. Carpio will also be co-responsible for developing the mural, in coordination with ARTogether and other community partners.

ARTogether will be the main organizer of the Project, and is responsible for logistical needs, community outreach, organizing Project events, and bookkeeping. ARTogether will also be co-responsible for on-site logistics, fundraising, communication/coordination with the City of Oakland, and meeting other administrative needs, in coordination with the Office of C.P. Nikki Fortunato Bas. Staff representatives of ARTogether for the Project will be Community Arts Program Manager Polina Marso and Development Director Miles Markstein.

The Office of Council President Nikki Fortunato Bas will be a major community partner for the Project, and will offer support coordinating with the City of Oakland for long-term maintenance and other Project needs, funding support, on-site logistics, and support for other administrative aspects of the Project.





Below are the materials and steps that are currently planned for the Project mural. Please note that all brand names listed are tentative, and may be subject to alternative purchases at similar price points.

<u>Pre-Mural Preparation</u>

- Power Wash the Wall (using rented Power Washer)
- Apply Seal-Krete Original Waterproofing Sealer
- Purchase: Tools, Scrapers, Brushes, Tarps, and Containers for Dirty Water/Paint

Priming, Painting & Sealing

- Power wash and prime wall with high quality exterior primer.
- Grid Wall: Enlarge gridded drawing of mural design to scale it up onto the wall.
- Paint mural with Nova Color Acrylic Mural Paint, with multiple sections painted in layers.
- When finished, seal the wall carefully with two coats of Precita Eyes Sheercoat Anti-Graffiti Sealer.






