OPD Chief Announces New Strategy to Reduce Violent Crime

Chief LeRonne L. Armstrong announced at a press conference today his plans to address the violence in his city. The Oakland Police Department (OPD) reports there have been 34 homicides this year. That is a 230% increase over this same time last year, when 10 people lost their lives to violence in Oakland. "It hurts my heart when I arrive at a homicide scene and I hear the screams of grief from the family and see the tears rolling down their faces after losing a loved one," says Chief Armstrong.

This year, 13 of Oakland's homicide investigations were charged by the Alameda County District Attorney's Office including, the homicide of 29-year-old Derrick Glenn. On March 24, 2021, Glenn was shot and killed at a gas station in the 2200 block of East 12th Street. OPD officers quickly arrested 34-year-old Brian LeGrand Jr. within 24 hours of the homicide. LeGrand was charged with Glenn's murder.

In response to the increase in crime, Chief Armstrong created the Violent Crime Operations Center (VCOC). The VCOC's primary focus is to provide a timely response to homicides, all gun-related crimes and supporting the Department's Ceasefire strategy. Since the implementation of the VCOC officers have made several key arrests of homicide suspects and recovered numerous firearms.

The Department continues to partner with Oakland pastors in monthly community prayer vigils. Last Sunday, Bishop Bob Jackson of Acts Full Gospel Church, led the vigil to end violence in our city. More than 100 people attended the event at Verdese Carter Park. Chief Armstrong thanks the community for their continued support in reducing gun violence.

The City of Oakland continues to see an increase in violent and dangerous illegal sideshows. In response to this violent activity, Chief Armstrong makes a weekly request to the City Administrator for the authority to deploy a dedicated sideshow enforcement detail. The officers focus on deterring, enforcing, and responding to this illegal activity. Because of these efforts, nearly 20 vehicles have been towed, 11 individuals were arrested, and two firearms have been recovered.

The Department continues to partner with community groups, regional law enforcement agencies, and other city departments for a long-term solution to address illegal sideshows and violent crimes in Oakland.

#OPDCARES initiative is about working together as a community to help stop the tragic loss of life and reduce the level of violence in our city. Collectively, we want to ensure Oaklanders and our visitors are safe in our community.

Six Vehicles Towed and A Portland Resident Arrested After Illegal Sideshows in Oakland

On March 28, 2021, there was illegal sideshow activity in the City of Oakland. The Oakland Police Department allocated dedicated resources to focus on deterring, enforcing, and responding to illegal sideshow activity with permission from the City Administrator.

At its height, 200-300 vehicles drove throughout East Oakland looking for an intersection to take over. The group was unsuccessful as officers on the ground, in OPD's Police Helicopter (ARGUS), and outside law enforcement agencies prevented this from happening.

Officers were able to observe and pinpoint specific vehicles driving recklessly. Officers made precision stops, issuing 10 citations, towing six vehicles, making two arrests, and recovering one firearm. One of the people arrested is an individual from Portland Oregon and is affiliated with a car club in that area. That individual also had their vehicle towed.

Illegal sideshows affect many cities throughout the Bay Area. The Oakland Police Department would like to thank the Alameda County Sheriff's Office, San Francisco Police Department, Vallejo Police Department, and California Highway Patrol for their regional communication that assisted OPD during this illegal activity. This regional approach and collaboration are crucial in successfully deterring and preventing illegal sideshows.

We encourage our community members and visitors to use the non-emergency email <u>sideshowtips@oaklandca.gov</u> It's a tip line where residents and visitors can report information regarding illegal sideshows, as well as vehicles and people involved in this illegal activity.

The email is an alternative to our non-emergency number (510) 777-3333 and is an additional means of collecting information about illegal sideshows. If there is an emergency or immediate safety threat, call 911.

OPD will continue working with our community and city partners to find the best means to deter illegal sideshows in Oakland. The department continues its commitment and dedication to investigating, enforcing, and preventing illegal sideshow activities from occurring in the City of Oakland. Officers collect information on vehicles for follow-up investigations and vehicle seizure warrants.

APRIL 2, 2021 UPDATE

Butte County Sheriff's Office (BCSO) detectives have continued working cooperatively with the Oakland Police Department (OPD) in our ongoing efforts to locate Ms. Dugger. Within the past week, the body of a deceased female was located in Siskiyou County. The Siskiyou County Sheriff's Office (SCSO), BCSO and OPD worked together to identify the deceased female using the BCSO ANDE Rapid DNA instrument.

On the morning of April 2, BCSO identified the deceased female as Ms. Dugger. BCSO, OPD, and SCSO will continue working cooperatively to determine the circumstances surrounding the death of Ms. Dugger. We encourage our communities to contact BCSO, OPD, or SCSO if they have additional information about the death of Ms. Dugger.

BUTTE COUNTY SHERIFF'S OFFICE SEARCH CONTINUES FOR MISSING PERSON

Oroville, CA – The Butte County Sheriff's Office (BCSO) continues looking for Tatiana Dugger, age 19, of Los Angeles. On January 09, Ms. Dugger's family contacted the Oakland Police Department and completed a missing person report. On January 13, the Oakland Police Department requested the Butte County Sheriff's Office assume jurisdiction of the aforementioned missing person investigation, since Ms. Dugger's family resides in Butte County.

On the afternoon of January 13, detectives interviewed Ms. Dugger's family members. After the interviews, detectives began conducting an investigation. During the investigation, detectives located evidence to include telephone records which indicate Ms. Dugger's last known location was in Oakland. Detectives determined Ms. Dugger moved from Butte County to Los Angeles approximately three months ago.

Butte County Sheriff's Office detectives continue to work cooperatively with the Oakland Police Department in our ongoing efforts to locate Ms. Dugger. Ms. Dugger is an African American female, 19-years-old, 5'7", 140 pounds, black hair and brown eyes. Anyone with information is encouraged to contact Butte County Sheriff's Office detectives at (530) 538-7671 or (530) 538-

7322 or the Oakland Police Department's Special Victims Unit/Missing Persons Unit at (510) 238-3641.

Oakland Deputy Chief Drennon Lindsey said, "The Oakland Police Department Missing Persons Unit Investigators will continue to provide support and resources to help the Butte County Sheriff's Office detectives and the Dugger family in locating Ms. Dugger." Deputy Chief Lindsey went on to say, "Investigators from OPD's Missing Persons Unit will meet with the Dugger family this Saturday and assist with passing out flyers of Tatiana Dugger."

Butte County Sheriff's Office Captain Steve Boyd said, "Our detectives continue working with the Oakland Police Department to locate Tatiana. We will not stop until we have located Tatiana. We encourage our community, other communities and our media partners to help us locate Tatiana."

Project Description

In September 2020, Leadership Incorporated was engaged by the Oakland Police Commission (OPC) to co-design and facilitate a one-day planning retreat. The work scope consisted of: (1) conducting police commission research and preparing a report; (2) interviewing OPC Commissioners and other affiliated individuals and preparing a report; (3) developing an agenda, facilitating the OPC retreat and preparing a report; and (4) developing a 2021 Action Plan. The contract period was September 2020 to March 2021.

 RE: Proposal to Revise Meeting Agenda Format

The Ad Hoc Rules Committee ("Committee") submits its proposal to reformat the meeting agendas for the Oakland Police Commission ("Commission"). The proposed format is illustrated by a sample agenda based on the March 11, 2021 meeting. Both a redlined and a clean copy of that agenda accompany this memorandum.

The Committee believes that revising the agenda format will (1) better inform the public and the other Commissioners about what to expect at meetings; (2) harmonize the meeting agenda with the revised Rules of Procedure the Commission unanimously adopted in February; (3) make the meetings run more efficiently; and (4) provide a roadmap for the meeting's Presiding Officer, something that will be important given the plan to have each Commissioner chair a meeting this year. The reformatted agenda would:

- 1. State the purpose of the Police Commission at the top of each agenda, and relieve the Chair of having to state the purpose at the beginning of each meeting. The Commission has been existence for four years now, and it seems unnecessary to orally state the purpose at each meeting.
- 2. Advise the public of the names of the current Commissioners, through listing each name as a part of the Roll Call process. The Committee notes that the City Council lists the names of each Council member as part of its roll call.
- 3. List each Open Forum as a stand-alone agenda item, and include an explanation of the purpose of Open Forum, so that the public is aware that comments should be directed to (1) matters that are not on the agenda; (2), matters that are within the jurisdiction of the Commission; and (3) matters that are of interest to the public. The agenda item would also provide notice to the public that speaking time can be reduced from two minutes to one minute.
- 4. Specify which ad hoc committees will report at each meeting, so that the Committee Chairs know that they need to be prepared to report, and the public and other Commissioners can better prepare for raising issues or concerns. The Committee notes that the agenda for the Public Ethics Commission specifies the committees expected to report, along with a description of the purposes of the ad hoc and its members. The Committee also suggests that, barring unusual circumstances, each ad hoc committee should report at least once each month, so as to keep the public and other commissioners apprised of the progress being made on outstanding deliverables.
- 5. For Open Forum Part 2, the agenda should clearly explain that this segment is not limited to people who were in the speakers' queue but did not get an opportunity to speak during Open Forum Part 1. This will assure the public that the Commission wants to hear from them, and that they will not be prohibited from speaking if they joined the meeting late or simply did not try to speak during Open Forum Part 1. This will also encourage people who intend to stay for the full meeting to hold their comments until Open Forum Part 2 so that others who cannot stay until the end of the meeting can speak. The agenda will also explain that speakers who made comments during Open Forum Part 1 should not expect to have a second opportunity to speak during Open Forum Part 2.



Resolution Adopting a Code of Conduct for the Oakland Police Commission

Introduced by Oakland Police Commission Ad Hoc Rules Committee (Members: Commissioner Henry Gage III, Co-Chair, Commissioner Brenda Harbin-Forte, Co-Chair, and Commissioner Sergio Garcia)

WHEREAS, Police Commissioners are public officials and have a responsibility to conduct themselves with the highest integrity and leadership; and

WHEREAS, Police Commissioners are responsible to all of the people of the City of Oakland, and not to any particular segment or group; and

WHEREAS, Police Commissioners must act in the public interest, not their private interests or any special interests; and

WHEREAS, Police Commissioners must strictly adhere to the legal and ethical requirements of office and avoid all situations where prejudice, bias or conflicts of interest could influence their decisions; and

WHEREAS, accountability for and between members of the Police Commission is promoted by the adoption of agreed-upon standards of behavior; and

WHEREAS, Rule 7.1 of the Oakland Police Commission's Rules of Order calls for the adoption of a Code of Conduct to which Commissioners are to be held accountable; now therefore be it

RESOLVED, that the Commission adopts this Code of Conduct in its entirety; and

FURTHER RESOLVED, that in accordance with the Oakland City Charter, the Oakland Municipal Code, and the Oakland Police Commission's Rules of Order, the following is established as the Code of Conduct for the Oakland Police Commission.

OAKLAND POLICE COMMISSION

CODE OF CONDUCT

A. <u>Commissioner Conduct.</u> Serving on the Commission is an honor. Commissioners shall conduct themselves in a manner that demonstrates civility, courtesy, honesty, integrity, decorum, and respect in all discussions, debates, and interactions with the public, fellow Commissioners, and City of Oakland representatives and staff. Commissioners shall observe the letter and the spirit of all state and federal laws, the Charter of the City of Oakland, the Oakland Municipal Code, Commission Rules of Order, and this Code of Conduct. To promote these ideals and to ensure the credibility of the Commission, all Commissioners shall:

- 1. Attend Commission meetings, except for absences excused by the Chair;
- 2. Fully participate in Commission meetings and other public forums attended by Commissioners, and demonstrate effective problem-solving approaches to the issues raised;
- 3. Prepare in advance of Commission meetings by familiarizing themselves with issues on the agenda;
- 4. Actively engage in their assigned Commission committees and meet applicable deadlines;
- 5. Be respectful of the time of others during public meetings by raising only appropriate points that advance the dialog and decision-making process;
- 6. Foster a collaborative working relationship with other Commissioners and engage in discussions with them in a manner that shows respect and appreciation for the varied backgrounds, skills and interests that each Commissioner brings, so that issues, concerns, and Commission business can be discussed openly and comfortably;
- 7. Respect differing opinions from others, and refrain from belligerent comments or personal attacks, shouting, or any other actions that could be construed as threatening or intimidating;
- 8. Actively and diligently support and implement final action taken by the Commission as a whole, even if the Commissioner did not vote with the majority on such action;
- 9. Maintain the confidentiality of all confidential information disclosed to Commissioners, unless expressly authorized by the Chair, the Commission's legal advisor, or court order to disclose such information;
- 10.Treat all staff as professionals and engage in clear, honest communication that respects the abilities, experience and dignityroficeacorimdisciduals and engage 30

- 11. Participate in the ongoing review and improvement of Commission procedures, such as this Code of Conduct.
- B. <u>Responsibilities of the Chair.</u> The Chair shall comply with all of the rules of conduct that apply to all other Commissioners. As the leader of the Commission, the Chair shall act in a manner that demonstrates an appreciation for the hard work and commitment of the other Commissioners. The Chair shall be open to input and suggestions from all Commissioners, and in particular committee chairs, before making decisions that affect the work of the Commission and its committees. The Chair shall ensure that Commission meetings are conducted in accordance with the Commission's rules of procedure and other governing authorities. The Chair shall also ensure that meetings provide opportunities for a full and respectful exchange of ideas and the responsible performance of Commission duties. To promote these ideals, the Chair (or other Presiding Officer) shall:
 - Confer with committee chairs in setting meeting agendas, and specify in each agenda precisely which committees will be expected to report at meetings, so that the Committee chairs and the public can adequately prepare for committee reports or other presentations at meetings.
 - 2. Publish meeting agendas that provide specific notice and explanations to the public and the other Commissioners about what they can expect to happen at Commission meetings;
 - 3. Maintain order and decorum and ensure the fair treatment of all speakers;
 - 4. Keep discussion and questions focused on the specific agenda item under consideration and ensure that discussion of related items advance deliberation of the agenda item;
 - 5. Manage the meetings in a manner that complies with all statutory and policy requirements, and seek advice from the Commission's Legal Advisor as necessary to ensure that compliance; and
 - 6. Ensure all agenda items are given the opportunity to be discussed and voted on by Commissioners in a manner that is fair, unbiased and reflects the positions of all of the Commissioners.
- C. <u>Interactions with the Public.</u> If Commissioners appear before or correspond with another governmental agency or organization or the public, they shall:
 - 1. Clearly articulate whether they are acting or speaking on behalf of the Commission or one of its committees, or in their personal or individual capacity;
 - 2. State the official Commission position on an issue, as reflected in a Police Commission 4.8.21 Page 31

Commission vote on the issue, whenever Commissioners speak as a representative of the Commission. If a Commissioner who did not vote with the majority on a matter wishes to speak to the reasons for the Commissioner's individual vote, the Commissioner should do so in a way that respectfully recognizes Commission deliberation and the vote of the majority;

- 3. Endeavor to channel media requests for background information or quotes through Commission staff to the Chair or Vice Chair;
- 4. Not make any explicit or implicit promises on behalf of the Commission as to a certain outcome related to any Commission action. Commissioners may appropriately give a brief overview of Commission policy, but should refer questions to the Chair, Vice Chair, or Commission staff for further information.
- **D.** <u>Social Media.</u> Commissioners are strictly accountable for their conduct at all times, whether in public or private, in person or through social media outlets. Commissioners have a right to engage in activity that is protected by the First Amendment. However, Commissioners who maintain personal social media accounts and publicly disseminate information related to the Commission's work must understand that their social media posts may discredit, undermine, or otherwise negatively impact the Commissioners shall exercise appropriate judgment when posting to social media, and shall refrain from attacking, retaliating against, or harassing other Commissioners, the Commission itself, and City staff.</u>

WHEREAS, accountability for and between members of the Police Commission is promoted by the adoption of agreed-upon standards of behavior; and

WHEREAS, Rule 7.1 of the Oakland Police Commission's Rules of Order calls for the adoption of a Code of Conduct to which Commissioners are to be held accountable; now therefore be it

RESOLVED, that the Commission adopts this Code of Conduct in its entirety; and

FURTHER RESOLVED, that in accordance with the Oakland City Charter, the Oakland Municipal Code, and the Oakland Police Commission's Rules of Order, the following is established as the Code of Conduct for the Oakland Police Commission.

RESOLUTION TO URGE THAT THE OAKLAND CITY COUNCIL AMEND CHAPTER 2.40 OF THE OAKLAND MUNICIPAL CODE

WHEREAS, the City of Oakland ("City") has codified certain restrictions related to City employment in Chapter 2.40 of the Oakland Municipal Code ("Ordinance") for the meritorious purpose of eliminating actual or perceived conflicts of interest, partiality or favoritism in the City workplace due to nepotism and/or cronyism and to maintain public confidence in the fairness of the City's hiring and employment practices as well as in the competence of City employees; and

WHEREAS, the Oakland Police Department presents special challenges to this important purpose because it utilizes strict chains of command that all go through the Chief of Police, and because the Ordinance as currently drafted could result in inequitable outcomes since it often is impossible for sworn members of the Police Department to transfer to other departments due to highly specialized training, duties, skills, and certifications related to delivering critical and highly regulated public safety services; and

WHEREAS, the Oakland City Council is considering whether it is in the City's best interest, and whether the Council desires to amend Chapter 2.40 of the Oakland Municipal Code to specifically address the potential for inequitable outcomes for the Police Department and Fire Department posed by this Ordinance, and in order to create an alternative process by which the City can avoid or mitigate inequitable or undesirable outcomes by granting the Director of Personnel specific authority to make alternate arrangements within these two departments;

WHEREAS, there are many employees throughout the City of Oakland's public safety departments who deserve the equitable considerations reflect by such a critical alternative process;

WHEREAS, if the City Council does not provide an alternative to this Chapter of the Municipal Code, we could lose exceedingly competitive and experienced professionals to other cities, which would not serve the interests of the People of Oakland; therefore be it

RESOLVED, that the Oakland Police Commission calls on the Oakland City Council to consider and support the proposed alternative process to change Chapter 2.40 of the Municipal Code.
