• Open Forum/Public Comment:

- Federal Task Force Transparency Ordinance OPD United States Marshal Service (USMS)
 - Review and take possible action on the draft memoranda of understanding (MOU) with federal partners

Deputy Chief Drennon Lindsey deferred to Lieutenant Scott Bezner to present on this item.

These items should be familiar to commissioners as they originally appeared in the November meeting packet. The Drug Enforcement Agency (DEA) MOU was given a favorable recommendation in November. The Privacy Commission ad-hoc met to review the USMS Taskforce and ATF MOU's.

In addition to the MOU, an addendum was included to address a policy on body worn cameras. This MOU is very similar to the language of the language in the ATF MOU. The USMS taskforce did accept the language that was proposed. Lt. Bezner indicated that changes to the document include the addition of OPD officers are allowed to wear their OPD issued body worn cameras during operations with the USMS.

Public Comment -

Assata Olugbala addressed the content of the MOU and stressed that it is extremely important that the cameras stay on at times. She mentioned the stop data and the impact on the African American community.

Lou Katz indicated that OPD can utilize body worn cameras as described in OPD policy.

Commissioner Brown had a questions about language in the document that states the recordings will be provided to the USMS. She also requested information data retention. Lt. Bezner indicated that the footage would be given temporary access to review it. The data will remain on OPD servers. The data is permanently housed in OPD.

Commissioner Suleiman requested information on the additional terms that were highlight in red on the final page. She had a requested about whether or not the City Attorney's Office reviewed the document. She requested clarification on the language "unless otherwise required by law." Lt. Bezner stated that the City Attorney's Office recommended this language and stated that taskforce members would need to refer back to OPD laws and regulations and/or California law.

Commissioner Oliver indicated that a lot of the language or tenure of this sounds like they own the footage. Other than thought he did not have any other concerns regarding the language in the document.

Commissioner Katz moved to approved that documents are forwarded to the Public Safety committee of the Oakland City Council. The motion was seconded by Commissioner Oliver.
