

Home Maintenance and Improvement Program (HMIP) Loan Program Description

PURPOSE:	The Home Maintenance and Improvement Program (HMIP) is a City of Oakland Housing Rehabilitation program that offers loans to owner-occupied low-income households to correct health and safety related repairs, including building code deficiencies. Loans are not made for payment or reimbursement of completed or in-process repair costs.			
REQUIREMENTS:

OCCUPANCY:	<ul style="list-style-type: none"> Single family residences must have been owner-occupied for a minimum of 1 year by low-income households. Two-unit structures must have at least one unit occupied by a low-income household. Three-to-Four unit structures must have at least 51% of the units occupied by low-moderate income households. All vested recorded owners of the property must complete the application even if they do not occupy the property.
