D. Community Action Partnership (CAP) Updates (E. Clemons)

1. Board Updates

A. New Board Member Orientation (T. Love and L. Guevara) – Rescheduled for Monday, September 13, 2021, at 4:15 p.m.

2. AC-OCAP Programming

A. AC-OCAP Update

The Community Services Block Grant (CSBG) 2021 contracts are executed, and staff D. Williams has finalized the 2020 Outcomes Reporting to the State. Staff V. Floyd-Rodriguez continues to work on providing The Coronavirus Aid, Relief, and Economic Security (CARES) Act monies to families; 250 Head Start families have already received their first allocation of funds. E. Clemons thanked AC-OCAP Grantees for submitting 2021 mid-year progress reports on time, allowing staff to begin the review process.

B. Bank On Oakland (BOO) and Guaranteed Income Update

The BOO 2.0 Inaugural Banking Partners Meeting was held on June 21, 2021 with federal and state updates, lessons learned, and the City of Oakland's vision among the topics covered. A soft launch of BOO 2.0 will come after the banking programs are vetted. Housing and Economic Rights Advocates (HERA) is the coordinating agency that is partnering with CAP to ensure the success of BOO 2.0 re-launched.

The first phase of applications for Oakland Resilient Families (Guaranteed Income Program) closed on the 30th of June. The second phase is scheduled to launch later this summer or early fall, with applications available to low-income households citywide. The Tri-Valley Career Center connects employers with qualified, skilled talent and job seekers with employment and career development opportunities to achieve economic prosperity. A. Lindo shared Career Center offerings, participant quotes, COVID challenges, and program outcomes.

Hack the Hood Inc. | Presenter: Tiffany Shumate, Executive Director

Hack the Hood provides youth with technological and professional training, coaching, and the support necessary to obtain techrelated employment. T. Shumate shared two success stories from the Internship Pilot Program, COVID challenges and pivots, staffing updates, participant demographics, and 2021 progress year to date.

New Door Ventures | Presenters: Brooklyn Williams, Program Director, and Kevin Hickey, Chief Program Officer

New Door Ventures assists disconnected young people to prepare for work and life by providing skills training, meaningful jobs, educational aid, and personal support. B. Williams and K. Hickey provided updates on activities and outcomes, as well as future plans to return to in-person work experience and initiate integrated cash assistance supports. *Youth Speaker* Randi Lauderdale, Leadership Council Alumni, shared her program experience.

Renaissance Entrepreneurship Center | Presenters: Bret Sweet, Center Director, and Ginelle Curincita, Program Manager

Renaissance Entrepreneurship Center promotes and enhances the entrepreneurial capabilities of people from various social and economic backgrounds, in order to establish sustainable new enterprises, new jobs, and financial self-sufficiency. This review is conducted in accordance with the provisions of Office of Management and Budget (OMB) Title 2, Code of Federal Regulations (CFR), Part 200, "Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards," Subpart F, Section 200.500 et seq.

The State Controller's Office (SCO) reviews the audit report to ensure that applicable standards have been met and to resolve outstanding matters regarding format, required statements, and items that appear to cut across multiple programs or funding sources. CSD's review is solely based on the single audit for the fiscal year ended June 30, 2020, and is not part of any other audit or investigation. The TR letter prepared by this department covers the statements as they pertain to CSD contracts. Based on our review, we have the following comments or actions required.

CONTRACTS: 19F-4002 and 19F-4405

The terms of these contracts were covered in the audit period. Since there were no audit exceptions, we consider these contracts closed.

CONTRACTS: 20F-3002 and 02F-3641

The terms of these contracts extend beyond the audit reporting period. Please ensure these contracts are included in the next single audit and that expenditures are identified by CSD contract number, program components (i.e., Weatherization and ECIP/HEAP/Assurance16; CSBG and CSBG Discretionary), and Catalog of Federal Domestic Assistance number.

Supplemental Statements of Revenues and Expenses that reconcile to the Schedule of Expenditures of Federal Awards are required for all contracts passed through CSD. These supplemental statements should also be broken down by program component, fiscal year, and CSD budget line item.

RELATED CONCERNS:

The single audit identified a material weakness in internal control over financial reporting pertaining to SEFA expenditures. The auditor noted, "...the City included expenditures incurred in fiscal year 2019 and 2020 [on the SEFA] that were not eligible for grant reimbursement in fiscal year 2019 and 2020..."

The City provided a corrective action plan stating it will "...take measures to ensure that personnel responsible for communicating federal expenditure data to the Finance Department are familiar with SEFA reporting requirements and emphasize the need for reporting federal expenditures on an accrual accounting basis. The City will develop procedures to ensure the completeness of the amounts provided by departments to be reported on the SEFA."

Although the finding did not pertain to CSD's pass-through funding, concerns exist that the CSD-funded programs may have similar issues in the future. CSD considers the issue closed since the agency provided planned corrective actions. However, CSD will review next year's single audit report to ensure the agency implemented the corrective actions.

CONCLUSION:

Our review did not disclose any findings requiring corrective action; therefore, the audit has been closed.
