SPECIAL ASSESSMENT EXEMPTION APPLICATION LOW-INCOME AND LOW-INCOME SENIOR HOMEOWNERS FOR THE 2025-2026 PROPERTY TAX

DEADLINE: Applications received **on or before May 15th** or next business day thereafter may be eligible for early exemption. Early exemptions remove the qualifying Special Assessment measures before the tax bill is mailed. Applications and qualifying documentation received after May 15th or the next business day thereafter may be eligible for refund exemption. Refund exemptions are check payments equal to the amount of the qualifying exemptions. Checks will only be issued after both property tax payments are made. Refund requests must be made within one (1) year of the final property tax payment.

To qualify for an exemption, complete and submit the following four (4) sections of this form and submit your complete income documentation.

Directions for Completing the Special Assessment Exemption Application

1. Please write clearly your name, phone number, email address, parcel number, the address of the parcel, and your mailing address. If your deed is under a maiden or married name that differs from your current name, please include the name(s) listed on your deed in "Other Names Used."

You may find your Assessor's Parcel Number (APN) in the top left corner of your Alameda County Secured Property Tax Statement.

The supporting income documentation must be submitted with the application. For households with more than eight members, please attach a second sheet with their information. Write the total number of residents and the total household income in their respective boxes.
 - a. Please submit the complete **Federal 1040, 1040-EZ, or 1040-SR** tax return of each resident.
 - i. **Schedule 1, Schedule C, Schedule E**, and Statements are important when evaluating gross income. If you file these documents with your 1040 and they are missing from your application, your application **will** be denied.
 - b. If the resident is not required to submit a 1040 form with the IRS, please submit documentation showing the resident's total income. Such documents may include Social Security Benefit letters, bank statements showing deposits, rent receipts, pension documentation, proof of age if over 65, and other award letters.
 - c. A No-Income Affidavit is required for any household member that does not receive any income, unless that household member is **both** age 26 or younger and listed as a dependent on the homeowner's submitted tax return.

 - d. Please submit a copy of your current **business tax license** if you rent property or operate a business in Oakland.
3. Please refer to the **Tables in the Qualifying Document** and check the appropriate box based on your household income threshold. If submitting for the Senior Low Income exemption, please include the proof of age.
4. The applicant should **sign and date** the Affidavit (Section 4 of the application).

Qualifying Documentation for the Special Assessment Exemption Application

1. To qualify for exemptions, you must:
 - a. Be the owner occupant of the property. We may request a copy of the trust document if we cannot determine the owner occupant.
 - b. Meet a low income qualification threshold.
 - c. Submit your application and qualifying documentation within the deadline.
 - i. **Early Exemption deadline:** Before May 15th or next business day thereafter
 - ii. **Refund Exemption deadline:** After May 15th or next business day thereafter, not more than 1 year from the final Property Tax payment

2. To qualify for the exemption, you must be the owner and occupant of the property. Owners occupants should have the Homeowners exemption under their Tax Computation Worksheet on the property tax. A trust document may be requested if we cannot determine the owner occupant due to a trust ownership.

4. Multiplex Parcels

The exemption amount granted may be less than 100% if the property is a multi-unit parcel. A parcel with five or more units does not qualify for exemption.

- 5. All persons who conduct business and/or rent property or rooms in the City of Oakland** are required to register and pay for an annual business tax certificate in order to be approved for an exemption. This includes any business with an Oakland operating address. Some examples include sole-proprietorships, gig economy workers, landlords renting Oakland properties.
