

#### **POPULATION GROWTH**


The population of these unincorporated areas rose from 133.112 in 2010 to 143.876 in 2019, a 7% increase.

#### TOTAL POPULATION (2010 VS. 2019)




#### ANNUAL EARNINGS






# STUDENTS PARTICIPATING IN FREE & REDUCED PRICED MEAL PROGRAM (2020-21)

### How does being an unincorporated area impact a community?

Unincorporated areas do not have their own municipal government. Government services, such as public safety, libraries, and road repair, are provided by the county. There is not a separate tax base to fund additional civil services, as in incorporated cities and towns. The result is that these areas may not experience the same level of service provision as incorporated cities and towns. However, property taxes are typically lower.
