**RESOLUTION AWARDING GRANT AGREEMENTS TO FAMILY BRIDGES, SPANISH SPEAKING UNITY COUNCIL OF ALAMEDA COUNTY, INC., VIETNAMESE AMERICAN COMMUNITY CENTER OF THE EAST BAY, VIETNAMESE COMMUNITY DEVELOPMENT INC., EDEN I&R INC., YOUTH TOGETHER, OAKLAND CHILDREN'S FAIRYLAND INC., CHABOT SPACE & SCIENCE CENTER, OAKLAND PARKS AND RECREATION FOUNDATION, FRIENDS OF PERALTA HACIENDA HISTORICAL PARK, EAST BAY ZOOLOGICAL SOCIETY, OAKLAND ASIAN CULTURAL CENTER, OAKLAND PROMISE, AND CENTRO LEGAL IN A TOTAL AMOUNT NOT TO EXCEED \$1,993,215.00 FOR FISCAL YEAR 2021-22 AND \$1,843,215.00 FOR FISCAL YEAR 2022-23.**

**WHEREAS**, funding for these grants has been appropriated in the General Purpose Fund in the proposed Biennial Budget for Fiscal Years 2021-23; and

**WHEREAS**, the General Purpose Fund grant funding appropriation for these grants is separate from any other City of Oakland funding that the above-named entities may receive in Fiscal Years 2021-23, including funds allocated from other funding sources, through separate grant or contractual agreements, or through voter-approved measures; now, therefore, be it

**RESOLVED**: That, upon adoption of the Biennial Budget for Fiscal Years 2021-23, the City Council awards grants to the 14 entities identified in **Table 1** above in the amounts specified therein for Fiscal Years 2021-22 and 2022-23; and be it

**FURTHER RESOLVED**: That these agreements are not professional services contracts as defined by City ordinance as they do not provide goods or services to the City but rather they are grants to private non-profit entities that serve the public at large, therefore the competitive request for proposal/qualifications process is not required under Oakland Municipal Code section 2.04.015; and be it

**FURTHER RESOLVED**: That the City Administrator is hereby authorized to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, payment requests and related actions necessary to achieve the basic purpose of this resolution; and be it

**FURTHER RESOLVED**: That, prior to execution, said grant agreements shall be approved as to form and legality by the Office of the City Attorney and fully executed copies of the agreements shall be placed on file with the Office of the City Clerk; and be it

**FURTHER RESOLVED**: That this Resolution shall take effect immediately upon its passage.
