| Proposal: | Revisions to an application originally reviewed by the Landmarks Board March 12, 2018. The proposal is to construct a new multifamily facility for 45 units in a former parking lot serving 3007 Telegraph and to remodel portions of the existing building at 3007 Telegraph which is a Potential Designated Historic Property. The new multifamily facility would have 47 parking spaces serving both the new and historic structures. The application is revised at the direction of the Landmarks Board to reduce the height of the portion of the building abutting the existing condominium project at 532 30th St. and retain portions of the historic structure originally proposed for demolition. The Board also recommended that the applicant modify the south and east elevations of the new building to make it less busy, increase transparency, and provide a distinctive design which is different from the historic property. |
