A. Call to Order/Approval of Agenda

Gladys Green called the meeting to order at 5:41 p.m.

- **B.** Roll Call/Determination of Quorum/Recite AC-OCAP Promise Roll call was called by staff S. Ellis. A quorum was established. The AC-OCAP promise was recited.
- C. Approval of Draft February13, 2018 Administering Board Minutes (G. Green) Motion: To approve the February 13, 2018 minutes. M/S/Carried: M. Rivera/T. Jackson/Motion carried.

D. Community Action Partnership Update/Action Items (E. Clemons)

1. Board Update

- A. Vacancies E. Clemons spoke about the District #1 Board vacancy. E. Clemons stated that a vacancy letter was sent to Council member Dan Kalb and that a District #1 CDBG mailing list has been received from Greg Garrett. G. Green also gave a copy of the CDBG mailing list to S. Ellis. Because this vacancy occurred during a regular term, the position will remain opened until filled. E. Clemons encouraged board members to share the vacancy information with community members.
- B. **Business Card** S. Ellis stated that three board members (T. Jackson. S. Johnson, and L. Ruhland) requested business cards; and that the business cards should be received by 3/15/18.
- C. Form 700 S. Ellis stated that six board members (S. Callum, B. Carter, M. Chacana, A. Ford, S. Johnson, S. Richardson, have submitted their Form 700. E. Clemons thanked board members who have already submitted their forms and encouraged other members to complete their Form

2. 2017 2018 Program Update

A. 2017 Annual Outcome Chart and Fact Sheet

E. Clemons gave an overview of these documents (which were included in the AC-OCAP Board package). She encouraged members to read the case studies on the back of the Factsheet, which shows that Community Action Partnership is helping to change lives. The case studies also highlights how AC-OCAP services impact lives. E. Clemons compared 2016 to 2017 data, and said that in 2017, 1 in 4 children (28.7%) live in poverty in Oakland and 20% of Oakland residents (81,567) are living below the federal poverty level. Additionally, Oakland Fund For Children & Youth (OFCY) is holding a community listening session. Information will be sent to the board regarding this event. Also, Children Now just released a new score card about the children in Alameda County health disparities. E. Clemons also said this is the reason why she is looking to collaborate with Oakland Head Start (perhaps a pilot program around some innovative services with Head Start families who are also using CalWorks services.) In 2017 we served over 70,000 individuals. 1,900 people received legal assistance - down from the year before. 19,000 youths in the Summer Lunch Program were served. 20,000 free tax reparations. 619 Alameda County low-income families were housed. 128 Alameda County low-income residents received employment. \$23.5 Million in tax refunds came back into Alameda County's economy. Additionally, E. Clemons said the 2018 Grantee contracts are complete. **ACTION:** Information concerning the OFCY listening session will be sent to Board members.

B. 2018 Programming

EITC (Earned Income Tax Credit)

E. Clemons spoke about this program and the criteria for receiving free tax preparation. This service is provided to families and individual who earn less than \$54,000 per year. There are over 200 locations throughout the Bay Area and over 200 volunteers. An intake center will be opened at the Oakland Business Assistance Center – 270 Frank HO Plaza, Oakland, CA 94612 starting Tuesday, March 27, 2018. E. Clemons said there is a poverty map that shows the location sites where services can be received. E. Clemons distributed EITC informational cards in English, Spanish and Mandarin.

ACTION: A map of all EITC sites will be distributed at the April AC-OCAP Board Meeting.

Winter Shelters

E. Clemons said although there are over 110 beds, 25 senior beds in the winter shelter program throughout Alameda County, additional services are needed.

C. Conferences

NCAF Conference – E. Clemons stated that she and G. Green will attend the 2018 NCAF Conference (3/19-3/24) in Washington, DC. Both she and Ms. Green stated that they contacted the office of Congresswoman Barbara Lee's and Senator Kamala Harris to set up a meeting.

NCAP Conference – E. Clemons stated that the 2018 conference will be held August 28-31 in Denver, CO. She encouraged board members who have not attended a conference to

attend.

Cal CAPA – E. Clemons stated this is another opportunity for board members to attend a conference. The 2018 conference will be held November 13-16 in Sonoma, CA. G. Green stated that attending the conferences afford board members the opportunity to learn more

about the community action agencies. Ms. Green also said she is willing to forgo going to a conference so that a board member (who has not attended a conference) could attend.

3. AC-OCAP Alameda County Presentation

A presentation will be given to the Alameda County Board of Supervisors – Social Services Committee on March 26, 2018 at 12:30 p.m. to 2:00 p.m. Board members will receive a copy of the presentation prior to the meeting. B. Carter will coordinate a meeting with Supervisor Wilma Chan and AC-OCAP Board members before the March 26th presentation. B. Carter will also send Supervisor Nate Miley a notification of this meeting. M. Rivera and S. Johnson will review and revise the "Ask" letter. A motion was made to accept the "Ask" letter. M/S/Carried. B. Carter/T. Jackson/Unanimous. Motion Carried.

ACTION: M. Rivera and S. Johnson will review the "Ask" letter before the Alameda County Board of Supervisors – Social Services Committee meeting on March 26th meeting.

ACTION: B. Carter will coordinate a meeting with Supervisor Wilma Chan. She will also advise Supervisor Nate Miley of the meeting.

ACTION: S. Ellis will send out an Outlook invite to Board members regarding the meeting.

E. Oakland Homeless Presentation – Lara Tannenbaum, Human Services Department

Lara gave an update on the homelessness in Alameda County and showed a PowerPoint presentation on "Ending The Crisis of Street Homelessness in Oakland."

Following the presentation, there was an open discussion regarding the homeless plight in Oakland. Board members asked numerous questions, voiced their frustrations and unanimously agreed that more supportive services should be available for the homeless. Ms. Tannerbaum answered numerous questions and shared her frustrations with the homeless plight. She stated that money is a key factor, coupled with supportive staffing, to ending homelessness.

ACTION: Sytara will send a copy of Lara Tannenbaum's presentation to Board members.

Executive Committee (G. Green) – G. Green shared highlights of the March 7^{th} Executive Committee Meeting. She spoke about the District 1 vacancy and said she has a list of potential candidate from a recent CDBG meeting.

Program Planning Committee – Lisa Ruhland shared highlights of the March 7th Program Planning Committee Meeting. One issue that the Committee would like to tackle is hosting a 2018 forum around homelessness and possibly partnering with other organizations.
