1. Call to Order/Roll Call/Determination of Quorum

Gladys Green (Chair) called the meeting to order at 5:41 p.m. Roll was called by staff member Sytara Ellis. A quorum was established.

2. 2017-2018 AC-OCAP Program Update

E. Clemons gave an overview of the 2017 Annual Outcome Chart and the 2017 Fact Sheet. She stated that there was a drop in the number of people that were served in 2016 and 2017. This decline was due to less people using the services. E. Clemons also talked about the homelessness issue and the Coordinated Entry System; which Lara Tannenbaum (Acting Manager, Community Housing Services) will elaborate more on during her March 12, 2018 presentation at the AC-OCAP Board Meeting. E. Clemons also stated that the Fact Sheet that E. Derenthal created is a beneficial tool that committee members can use when talking about the AC-OCAP program and services.

3. (AC-OCAP) Alameda County Update.

E. Clemons read a draft "Ask" letter that will be presented to the Alameda County Board of Supervisors-Social Services Committee. Afterwards she asked for comments. Several members shared suggestions regarding the wording of the letter. E. Clemons stated that the letter was only a draft. She asked M. Rivera and A. Ford to work on the letter; and E. Clemons asked M. Rivera, A. Ford and S. Johnson to review the letter prior to the March 12th AC-OCAP Board Meeting. E. Clemons stated that since Supervisor Wilma Chan is the President of the Alameda County Board of Supervisors, a meeting should be set-up with her, the AC-OCAP Board Chair and Vice-Chair; at which time the "Ask" letter will be presented.

Act (**CA Code Section 54972.** On or before December 31 of each year, each legislative body shall prepare an appointment list of all regular and ongoing boards, commissions, and committees which are appointed by the legislative body of the local agency. This list shall be known as the Local Appointments List. The list shall contain the following information: A list of all appointive terms which will expire during the next calendar year, with the name of the incumbent appointee, the date of appointment, the date the term expires, and the necessary qualifications for the position.)
(b) A list of all boards, commissions, and committees whose members serve at the pleasure of the legislative body, and the necessary qualifications for each position. She also stated that some of the board member terms are not correct. A meeting has been set up with Yvonna Cazares (of the Mayor's Office) for Friday, March 16th to discuss AC-OCAP vacancies, Boards and Commission terms.
