



# 2022 Contribution and Voluntary Spending Limits Adjustment

The Oakland Campaign Reform Act (OCRA) limitations on contributions made to political campaigns and voluntary spending limits for campaigns are adjusted annually to reflect changes in the cost of living.

### **2022 Campaign Contribution Limits**

Candidates who accept the voluntary spending limit by filing OCRA Form 301 may accept contributions to their campaign committee from individuals, businesses, and other organizations of up to \$900 per election cycle, and contributions from qualified broad-based political committees of up to \$1,800 per election cycle.

Candidates who **do not** accept the spending limit may accept contributions from individuals up to \$200 and contributions from broad-based political committees up to \$400.

### 2022 Officeholder Account Contribution Limits

Annual contributions made to officeholder accounts are subject to the same contribution limits that apply to candidate committees. Elected City officials who adopted the voluntary spending limit may accept contributions to their officeholder account from individuals, businesses, and other organizations of up to \$900 per year, and contributions from qualified broad-based political committees of up to \$1,800 per year.

Officeholders who did not adopt the spending limit may accept contributions to their officeholder account of up to \$200 from individuals and businesses and up to \$400 from qualified broad-based political committees per year.

## 2022 Voluntary Spending Limits Increase

The Voluntary Spending Limits increased for all elected offices. A complete list of 2022 Campaign Contribution and Spending Limits follows below.
