Oakland Secures \$3.5M Grant to Enhance Community Safety

The City of Oakland and Family Bridges to Expand Safety Ambassador and Mediator Program

Oakland, CA – The City of Oakland has been awarded a grant of \$3,558,991 by the California Department of Social Services (CDSS) under the Community Response Initiative to Strengthen Emergency Systems Act (C.R.I.S.E.S. Act) Grant Pilot Program. This funding will be utilized in collaboration with Family Bridges, Inc., to significantly expand the safety ambassador program in Downtown and Chinatown, with plans to expand to Jack London Square, Little Saigon, and Lake Merritt in future years. The program deploys mediators trained in de-escalation and trauma-informed care to help people experiencing non-emergency, non-medical crises. The program proactively builds relationships with community members to co-create a safe, secure, and inclusive environment and is complementary to MACRO (Mobile Assistance Community Responders of Oakland)..

The Oakland C.R.I.S.E.S. Act Pilot Program, administered by the Economic and Workforce Development Department, will operate through August 31, 2026. Family Bridges will prioritize its Community Ambassadorship efforts through Mediators. In addition to providing de-escalation and trauma-informed care, Mediators will extend housing/systems navigation services, establish a dedicated hotline, and actively engage with the community through street outreach, mediation, and connections to resources, as well as events and booths. The pilot program is designed to reduce law enforcement and emergency medical response to non-emergency, non-medical incidents, freeing public safety resources, including police officers, paramedics, and 9-1-1 dispatchers.

The Oakland City Council will consider the grant and program approval at the February 27th meeting of the Community and Economic Development Committee, with the potential for full City Council approval on March 6. Upon approval, the Economic and Workforce Development Department will collaborate with Family Bridges to launch the program swiftly.

The C.R.I.S.E.S. Act Pilot Program, established under Assembly Bill 118, allocates \$9.5 million in grant funds statewide to support community-based organizations in developing emergency response pilots. The City of Marin (\$1.3M), Sacramento County (\$2M), and San Cruz County (\$2.5M) also received grants. The City of Oakland secured the most extensive grant amount in the state.
