What is Domestic/ **Intimate Partner Violence**

You always have the right to be safe. You do not deserve to be hit or threatened, and you should never be made to feel afraid for the well-being of yourself or others in your relationship

Intimate Partner Violence (IPV) occurs when one person shows a pattern of behavior to maintain power and control over another person in an intimate relationship. This behavior can include the use of physical and sexual violence, threats and intimidation, emotional abuse, and financial control

Those friends and family may be unaware of the abuse, may be unsure how to help, or they may have chosen not to help or support you. Further, they may not recognize the abusive behavior as a problem. If you or someone you know is with a partner who is abusive, consider getting support from a victim advocate who understands the dynamics of what you are going through. VINE allows survivors, victims of crime, and other concerned citizens to access timely and reliable information about offenders or criminal cases in U.S. jails and prisons. An offender can be held only up to 48 hours and, in most cases, he/she can bail out of jail at any time. To find out what prison or jail the offender is in and sign up to be notified when the offender will be released, call the VINE line above.
